a. Request for Proposal [RFP] for Audit - FY Ending 2018 through 2020:

There was BOF consensus their 2018-2019 Budget Line Items would be voted on once the Auditor is chosen and their fee is known.

- 8. New Business:
 - a. State Department of Education Additional FY 2018 Reduction to Educational Cost Sharing:

There was review of the State of Connecticut, Department of Education, 2017-2018 Revenue Cost Estimate Reductions correspondence, dated January 29, 2018, from Kathy Dempsy, Chief Financial Officer. The correspondence indicates the State Department of Education has issued an additional FY 2018 cut to Education Cost Sharing (ECS) of <u>\$78,389</u> for the Town Franklin.

BOF held discussions on significant impacts that will be felt by Town of Franklin residents both from a Town operational standpoint and Board of Education standpoint

A discussion should take place with the Franklin Board of Education about this additional 2018 cut, how the budget will be impacted, and how all those involved with budget planning should proceed between now and June 30, 2018.

Peter Calvert, BOE Chairman, indicated their budget is currently experiencing a \$12,000 shortfall prior to considering the additional reduction of \$78,389 as noted above. The Board of Education has been very responsible in utilizing budget funds. The Board of Education is deeply reviewing the current and future budget situations and is committed to continuing to providing quality education for Franklin students.

b. Discussion with Board of Education on FY 2019 Tentative Education Cost Sharing Reduction:

There was concurrence between the BOF and BOE to work cooperatively in looking at the possibility of a FY 2019 ECS significant reduction and are committed to finding ways to remain financially responsible knowing there are challenging times ahead.

- c. Status of 2017 Audit: The current auditor has received a 30 day extension. It is anticipated, a presentation outlining the report will be provided to BOF sometime in mid March.
- d. Discussion and act on spending freeze 2018: The following correspondence was read into the record:
