# a. Discussion & Action on Proposed FY 17-18 Municipal Budget to be presented at the Town Meeting scheduled for June 22, 2017:

There was review of the document titled "The Franklin Board of Finance 2017-2018 Proposed Budget - Annual Town Meeting June 22, 2017". Discussion took place about the FY 2016-2017 Approved Budget, the FY 2017-2018 Proposed Budget, and the Increases and/or Decreases from the 2016-2017 prior year Budget.

It was noted, the State of Connecticut has not released information about revenue funds for the Town of Franklin FY 17-18. Therefore, State revenue numbers are not included in the Budget Report document as reviewed and noted above; and is causing a 3.91% Mil Rate increase over FY 16-17.
