1. Call to Order: Chairman Handfield called the Regular Meeting to order at 7:30 p.m.

- 3. Public Hearing: Chairman Handfield opened the Public Hearing at 7:35 p.m.
 - a. Proposed Board of Selectmen Municipal & Board of Education Budgets FY 2020-2021:

<u>Board of Education FY 20-21 Budget</u>: Larry Fenn and Peter Calvert provided a brief overview of the current proposed budget as submitted and presented. Larry Fenn talked about areas within the budget that were reduced in order to propose a 0% increase. This budget proposal is based on a "normal" school opening and operations for the next school year and does not take into account possible COVID-19 guidelines that may be imposed by the State of Connecticut.

> Current proposed budget amount is \$4,000,675,00 – with a 0% increase

*Richard Weingart entered meeting at this point.

The Board of Education could experience significant increased costs due to social distancing guidelines at an estimated 13% to 20%. However, there could be a reduction in budget costs if the option of distance learning is used at an estimated 13% to 15%. Administrative Staff and the Board of Education continue to review various re-opening scenarios associated to COVID-19.

*Richard Weingart was seated and Roland Mihok was returned to an alternate members.

Pamela Flaherty noted the budget process is very complicated for residents and tax payers due to COVID-19. She is concerned that the foreign language programs have been eliminated due to budget reductions. In addition, the Art/Music programs were also eliminated. It should be noted many people have worked hard to get these programs running and students greatly benefit from foreign language studies both at the elementary and secondary educational level.

<u>Board of Selectmen FY 20-21 Budget (Municipal)</u>: Charlie Grant provided a brief overview of the current proposed budget as submitted and presented. The Board of Selectmen approved various reductions throughout the municipal budget to allow for a proposed 0% increase.
