 - a. Monthly Tax Collection Report: Kelsey Allard presented the Tax Collectors Report:
 - > 53.91% 2019 Grand List taxes collected
 - > \$47,055.60 prior year taxes collected
 - > \$7,409.76 interest and lien fees collected
 - b. **Monthly Board of Selectmen Income Report**: BOF reviewed FY 20-21 Income Report as submitted. Mr. Grant noted the budget is where it should be for this time of year. He also noted, Educational Cost Sharing fund from the State of CT has not been received, the new tenant at the Town Municipal Complex has paid two months in rental income and is progressing well, and a few major companies in town have paid their due taxes in support of the Franklin tax-base.
 - c. **Monthly Board of Selectmen Expense Report**: BOF reviewed FY 20-21 Expense Report as submitted. Mr. Grant noted the budget is approximately 25% across the board.
 - d. **Monthly Board of Education (BOE) Report**: BOE Chair Mr. Calvert reviewed the current budget. Funds are expected to be received from the Green Valley School Program for its rental use of Franklin Elementary School buildings and staff services provided for their program. COVID-19 reimbursement funds are also expected. These funds will off-set the BOE current budget.
 - e. Monthly Selectman's Report:

<u>Department of Public Works [DPW]:</u> The over the rail mower arm has been replaced and the Town of Sprague has agreed to pay half the cost. Sprague provided public work services for Franklin when the mower was not in service. The Pleasure Hill Rd. Culvert replacement is complete.

<u>Audit Report:</u> Auditor has begun the audit report process and is working with Town Staff. A possible draft report will be available in December.
